

## CCIL Broad and Liquid Index

### Introduction

The government securities market is considered as the backbone of fixed income securities market and is the prime funding avenue for the government. It serves as a benchmark for portfolio management, an indicator of market performance and development, and also forms the basis for derivative products like options and futures. CCIL Broad and CCIL Liquid are the two indices that serve as benchmarks against which the performance of bond markets can be measured. CCIL Broad index consists of top 20 traded bonds and the CCIL Liquid index constitutes top 5 traded bonds, respectively.

### BOND INCLUSION RULES

**Data Source:** Traded executed and reported on the Negotiated Dealing System- Order Matching (NDS-OM) platform

**Issuer:** Central Government

**Price:** Volume weighted average price (VWAP) or model price when there are no trades

**Tenor:** Minimum tenor is 1.5 years (Residual maturity on the index resetting date is considered)

**Base Date:** December 31, 2003

**Base Value:** 1000

**Weighting:** Market Capitalization

**Rebalancing:** Monthly

**No. of Bonds:**

- Liquid Index has 5 bonds
- Broad Index has 20 bonds

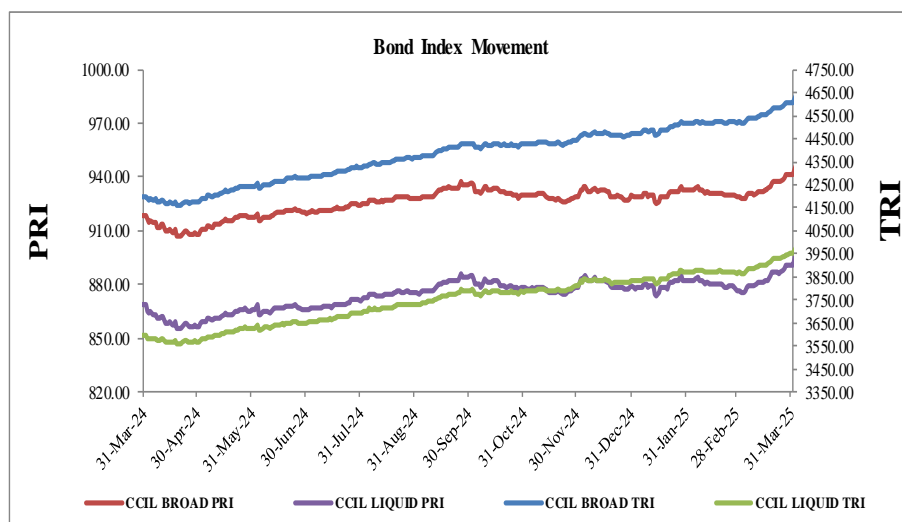
