## <u>Securities Settlement Segment</u> Increase in Margin Factors for Special Securities

Margin Factors are presently arrived at security-wise based on Value at Risk for a 3 day holding period (at 99% confidence level).

2 It has been observed that there is very low liquidity in the market for Central Government Special Securities. It has accordingly been decided that the Margin Factors of these securities will henceforth be stepped up by a specific multiple depending on the liquidity observed in such securities in a particular calendar Quarter. The Margin Factors for such securities would be as under:

- For semi-liquid securities (minimum average of 10 trades per day) at 1.5 times of the usual margin factors\*.
- For illiquid securities (less than average of 10 trades per day), 2 times of the usual margin factors\*.

The changes as above will be effective from the Reporting Friday dated 8<sup>th</sup> June'07.
